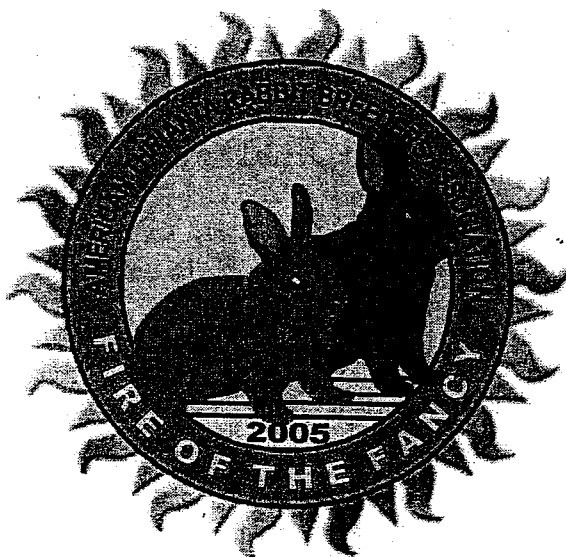

I do want to mention and give a big thank you to Dr. Wesley E. Kloos, Professor Emeritus of Genetics, North Carolina State University for contributing an article on the genetics of our Thrianta for our guidebook. I met Dr. Kloos at a show I was judging in North Carolina this spring. We had a very enjoyable visit. I was surprised to learn that he was a rabbit enthusiast and breeder for many years as well as a licensed ARBA judge. After returning home I contacted him and asked if he would do some research on the genetic makeup of our breed for publication in our guidebook. He agreed and what a wonderful, informative article he wrote. I'm sure you will agree when you read it.

As for the upcoming ARBA National Convention in Louisville, I have not received the catalog for this show yet but I'm told that the deadline for entries is very early in September. If you plan to enter, make certain that your entries are on time. We plan to have an auction for our Thriantas on Wednesday after the breakfast. The demand for our little red rabbit is soaring so I hope that some of our exhibitors will designate one or more of their animals for the auction. It will be fun, exciting, and profitable for the donor and our club.

Earlier this summer, Bill Mairs contacted me with a concern about the proper "head set" of our Thriantas. It seems that some exhibitors and judges have been pushing the heads down to the table much like Florida Whites or Dutch. Others like to hold the head high like that of a Holland Lop or a Netherland Dwarf. He requested that our breed standard committee come up with a statement as to the preferred head set for the Thrianta. He sent a number of pictures showing various poses and head sets. As most who try to photograph live animals, in particular, rabbits, it is a difficult task to achieve exactly what is wanted. Anyone that wishes to discuss Bill's request of making a more defined statement about the head set, please feel free to send your thoughts to me. Pictures of desired head sets are welcomed and encouraged. One good picture is worth a 1000 words. I'll pass them on to our breed standards committee for evaluation. We need to get any proposed changes to our current standard submitted to our membership in the next newsletter for a vote to meet the deadline set by the ARBA for submitting changes for its consideration and approval for the next official standard.

For now, all breeders and judges should be encouraged to pose the breed with the head set in a natural pose, not pushed down nor raised high to show any extension of the front legs. The standard now describes the top line of the body to rise in a gradual arch from the back of the ears to over the top of the hips. The head set being too low or too high would adversely effect a proper top line of the body.

That's about all I have for now. I hope to see many of you in Louisville.

Our standard states they have a compact body with enough length to carry the weight, and gradual curve from neck to center of hips. I find I get the desired results on my interpretation of the standard by posing them lightly on their front fee. (low stance). I feel we as breeders should spend time with a judge after judging to show them what we are looking for. Some judges will always look at them as a red Florida White and we will never be able to change their minds, but remember when house training a puppy, if you keep working with them you finally get the desired results.

With the national economy in the sewer, gas and rabbit feed competing to see which one will hit the high for the month, it does not leave much for discretionary spending. This year I will again be asking for award donations. All I ask is donate what you can.

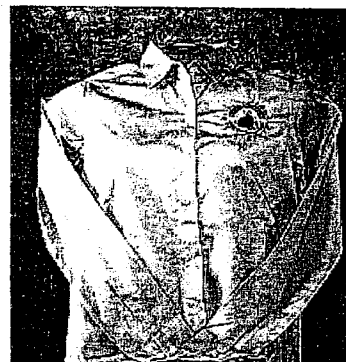

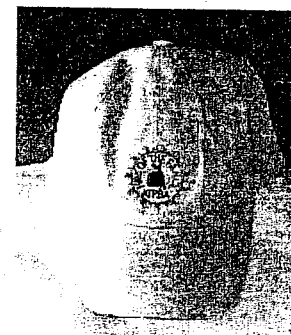
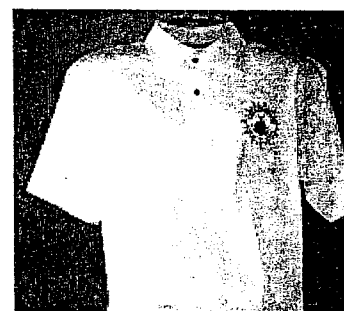
